VII. Electronic Periodical Resources and Databases

- A. LexisNexis Academic. A huge database of millions of documents from over 5,900 news, business, legal, medical, and reference publications, LexisNexis Academic provides online access to continuously-updated archives of state and federal statutes, regulations, and case law. Most documents are available in full text online. To do legal research, click on the "Legal" button at the top of the initial screen. If you already have a citation number or case name for a case and want the



full text of the opinion, click on “Federal & State Cases” at the left. Then, enter either the party names or the citation. To search for relevant cases by topic, enter your terms in the search box at the top. [This database is also available off campus to PSU students, faculty, and staff. Connect via the Plymouth portal: <http://my.plymouth.edu> -- then go to the Library Home Page and follow steps noted above.]

- B. Academic Search Premier. Provides indexing and full text articles from over 8,000 scholarly and popular publications covering all academic subjects. **Note: This database is the recommended starting point for most searches for periodical articles.** Connect as indicated above. Use the “Subjects” button at top of screen to verify subject terms. For a Tutorial Slidecast on how to search Academic Search Premier, click the INFO button next to the database name. [Also available off campus; connect via the Plymouth portal, as described above.]

- C. ERIC. The Educational Resources Information Center (ERIC) database is the most comprehensive database for locating articles and documents in Education and related subjects. The database indexes articles from over 980 education journals and from over 400,000 ERIC Documents (these may be papers presented at professional conferences, curriculum guides, lesson plans, and other education-related documents). While there are free Web links available to ERIC, the most efficient way to search ERIC is via EBSCOhost -- links to any full text articles or documents will appear under citations. *The ERIC database does not contain any full text articles, but the EBSCO version of ERIC will provide a link to the full text of any article which is available in one of its other databases.* Use the “Thesaurus” button at top to verify subject terms. Coverage from 1966 to present. Lamson Library has all ERIC documents (ED numbers) on microfiche; those documents published from 1993 to present may also be available in full text online; ask for assistance at the Reference Desk. For a Tutorial Slidecast on how to search ERIC, click the INFO button next to the database name. [Also available off campus; connect via the Plymouth portal, as described above.]

VIII. World Wide Web

There are many legal resources available via the Internet on the World Wide Web. Some of these have already been cited above. A large number of valuable Education-related law links may be found by going to the Lamson Library Home Page, clicking on “Resources by Subject” (at left), then “Education”.
